<u>Robert B. Famiglio, K3RF</u> Addendum to Director Candidate's Questionnaire

In response to Question 4B, the Candidate answers as follows:

100% owner of FAMIGLIO & ASSOCIATES law practice.

12% owner of Delmonte Equity Partners, a real estate holding company.

100% owner of nonprofit entity - Emergency Communications Radio Auxiliary Team. This Pennsylvania nonprofit association provides volunteer support for public safety communications in emergencies and as a public service.

In response to Question 4C, the Candidate answers as follows:

The applicant is employed by his law firm, FAMIGLIO & ASSOCIATES, a professional corporation in the state of Pennsylvania. The applicant is owner of a limited partnership interest in land as set forth in 4B above. No HOA interest of any kind is involved. The applicant also has numerous financial arrangements for conventional investments with numerous banks and credit unions in the form of money market accounts and certificates of deposit. Further, applicant has financial arrangements with Wells Fargo, through its HD Vest retirement accounts mutual fund. None of these entities have any relationship with a ham radio company nor are they in any for-profit business dealing with amateur radio directly or indirectly as far as known by applicant. Further, applicant is presently providing trademark services to the Quarter Century Wireless Association, disclosed in writing last year. Applicant also continues as attorney of record in DePolo v. Tredyffrin Township, antenna litigation case also disclosed. Applicant has many clients in an active legal practice but none which are known to be in any amateur radio related business.

In response to Question 4D, the candidate answers as follows:

The applicant was ARRL Eastern Pa Section Manager from 2012 until taking office as ARRL Vice Director of the Atlantic Division in April 2015. Prior to that, applicant was ARRL Eastern Pa First District ARES Emergency Coordinator in 2006 until 2012. Various minor appointments for ARRL were held earlier. Applicant has been an ARRL volunteer legal counsel since the beginning of the program. Applicant provides free legal consultations to ARRL members calling with legal questions related directly to amateur radio activities, including antennas, RFi, club administration and liability. He is one of the original volunteer counsel for the ARRL, involved since the program started. His major focus in radio is emergency service as well as new technologies. Radio officer and emergency first responder (Lieutenant for 6 years - elected company captain beginning January 2015 to December 2017) for Rose Tree Fire Company (Station 73) in Media, PA.
